The organization's mission is to promote academic excellence through the expansion of resources that enrich the education, development, and well-being of students in the district. The Amphi Foundation's efforts are centered on three focus areas. 1 Student Preparedness - Shoes, clothing, school supplies and other basic needs so children are prepared to fully engage in learning. In FY 2023-2024, \$35,600 was invested in this area. 2 Innovative Learning Opportunities for Students & Educator Support - Classroom technology, maker spaces, music program support, classroom & school wide grants, and professional development for teachers.
